## Pilot Project Addressing Energy Poverty on Halting Sites

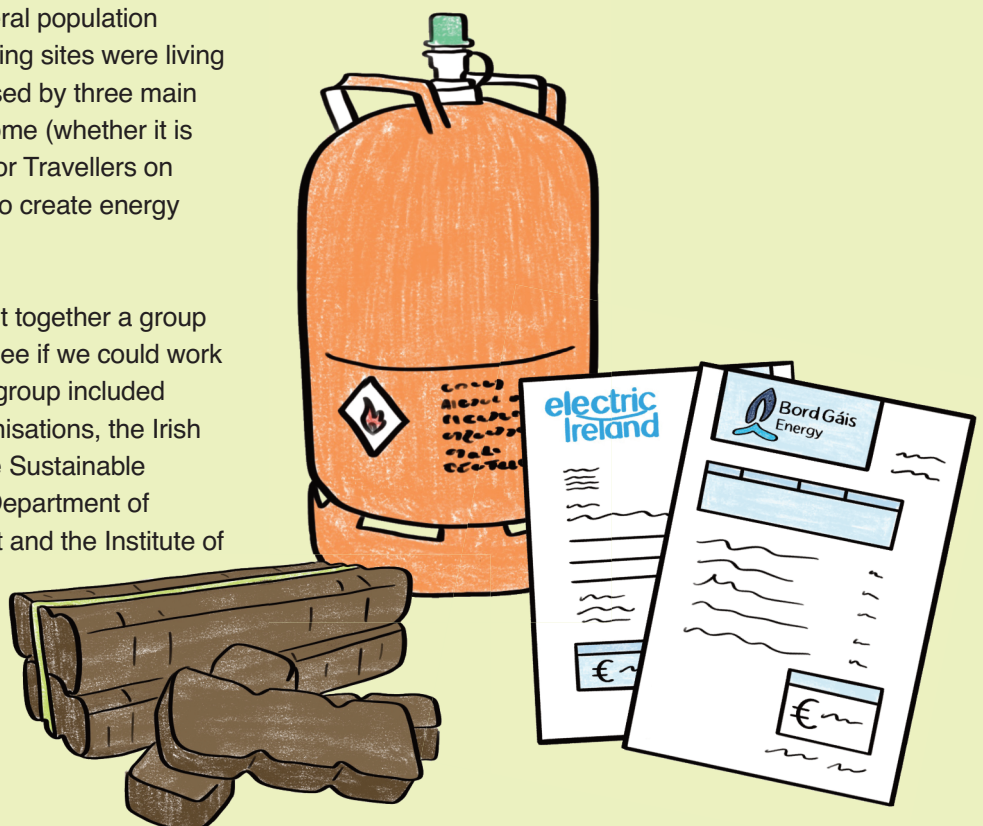
For many families the cost of energy is a big part of their weekly spending. In fact, over recent months this has become an even bigger problem as we have seen gas and electricity price increases as well as additional carbon taxes. National Traveller MABS is aware that many families find it hard to meet the cost of energy and have to borrow from family members, go into debt or go without. Some families self-disconnect during the winter months. For families living on halting sites this is an even bigger problem as trailers and mobiles are very expensive to heat because of their poor insulation. Quite often there are other issues on sites including not being able to get accurate meter readings and problems with the way gas and electricity are supplied. For families who are sharing a bay, some are not able to get the winter fuel payment or fuel allowance.

Back in 2018, National Traveller MABS worked with other local Traveller organisations and MABS services to look at this issue. We did a study that found families living in halting sites spend an average of €108 per week on energy. In the general population this figure is €39 per week. The study found that families on halting sites spend just over a quarter of their income on energy, while the general population spend about 4%. 75% of families on halting sites were living in energy poverty. Energy poverty is caused by three main issues, low income, the quality of your home (whether it is well insulated) and the price of energy. For Travellers on halting sites all of these issues combine to create energy poverty.

In 2021, National Traveller MABS brought together a group of people from a number of agencies to see if we could work together to solve this problem. This new group included representatives from local Traveller organisations, the Irish Traveller Movement, local authorities, the Sustainable Energy Authority of Ireland (SEAI), The Department of Housing Planning and Local Government and the Institute of Technology Sligo. This group agreed to develop a pilot project on one or more halting sites. This project is trying to understand the problems and carry out actions to address them. We will

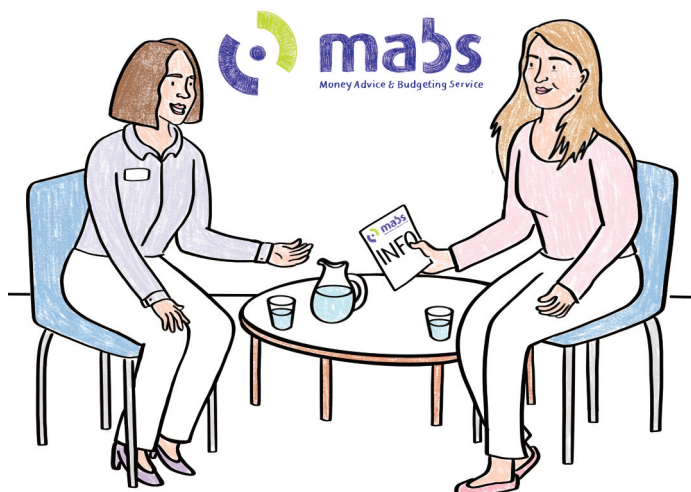
evaluate and write up what we learn as a model of good practice. This model will look at the day units, the trailers/mobiles and also how energy is supplied on the site. In case of the day unit/house we will look at insulating and retrofitting. In terms of the supply of energy we will explore new technologies including solar panels heat pumps and wind turbines. With the trailer or mobile homes, we will look at how better quality homes might be provided to families at affordable prices. Currently there is one pilot site identified and discussion is underway with one local authority to run a pilot on the site. SEAI or the Sustainable Energy Authority of Ireland will part fund the pilot project/s. Once agreement from the local authority (as they have to apply for funding) is in place, engagement with families will begin.

The aim of this project is to develop models of good practice that can be shared with other local authorities and inform how Traveller Accommodation on halting sites is delivered. We will work for this good practice to become government policy and incorporated into the design and delivery of Traveller Accommodation. The aim is to eradicate energy poverty for Traveller families living on halting sites.





## Dublin South Community Engagement Pilot



National Traveller MABS is part of the MABS network. One of our key aims is to resource and support MABS/CIS to develop policies and practice to make their services more accessible to and appropriate for Travellers. Achieving equality in service provision is an ongoing task for all MABS staff.

Staff of Dublin South Region MABS met with staff of National Traveller MABS in early 2021 to discuss how we might work together to improve access to services for Travellers in the region. They agreed to pilot a Community Engagement programme in the Dublin South Region. The main aims of the pilot are:

- To increase engagement of the Traveller community in MABS in the Dublin south region.
- To increase cultural competency of staff of Dublin South Region MABS in relation to Traveller culture.
- To develop and strengthen relationships between MABS and local Traveller organisations in the Dublin South Region

All eight services in the Dublin South region agreed to take part. Each service assigned a designated point of contact who would coordinate with their staff. The group met a number of times and agreed on the objectives of the pilot and a project plan. Services have committed to undertake Traveller cultural awareness training, information sessions about the financial issues affecting the Traveller community as well as relationship building with their local Traveller organisation.

A toolkit for MABS staff engaging in the pilot is available on the CIB Learning System which contains factsheets about the Traveller Community, Traveller accommodation plans for South Dublin, National Traveller MABS publications, information about Traveller specific support services, information about Traveller culture and History, information about plain English and community education resources.

As part of the pilot a booklet for MABS staff detailing Traveller specific support services was developed. This is available as part of the toolkit and will be circulated to all MABS staff.

Due to the lack of an ethnic identifier in the MABS system we lack quantitative data on the number of Travellers accessing the services in South Dublin. To combat this we have developed a baseline questionnaire to evaluate where MABS services were before the pilot and this will be re-run at the end of the pilot to measure any changes. The pilot will be fully evaluated at its conclusion and we hope to replicate it in other MABS regions.

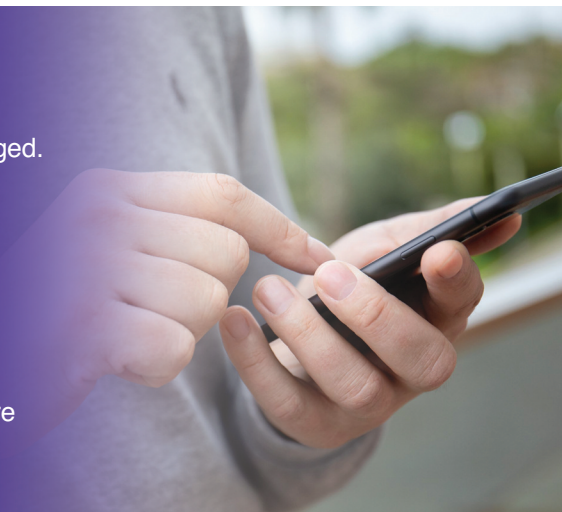
Please be aware that due to ComReg changes our phone number has been changed.

Calls to 0818 will cost the same as to the previous 0761 numbers. Calls to 0818 are included in call bundles or will cost no more than calling a landline.

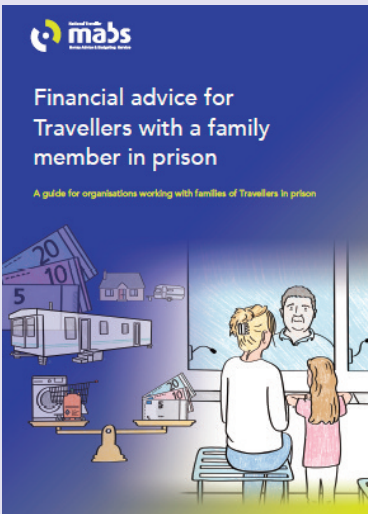




### Extra Bank Holiday 2022
